Key Points of the Proposed Experimental Bye-laws Changes (initial 2-year implementation) (Revised)

Proposed Competition Bye-law changes for more flexible player registrations and other points to note if such changes are introduced - NB: these are all taken from Bye-laws from other countries.

- 1. [Existing Bye-law] Remove Designated Under 21 Players Rule;
- 2. [Existing Bye-law] Maintain Dual Registration Nominated Players for Goalie and Outfield and such players cannot move up or down in their respective outfield or goalie registered team without WS committee approval (i.e. this is the current rule anyway)
- 3. [New] General Rule (core / non-core players) League only:
 - I. Each registered team will have 9 named Core Players
 - Core Players cannot move down for a lower-ranked team
 - Core Players of a lower-ranked team may be able to play up one grade within their club (higher-ranked team) with restrictions and may not double up.
 - The Core Player registered for a lower-ranked team may only play for a higher-ranked team for a maximum of three (3) matches during the full season. This includes league, cup and tournament matches. For the avoidance of doubt, one-day divisional tournaments shall be deemed to constitute one (1) match.
 - Once she has played four (4) matches for the higher-ranked team, she will be automatically registered for the higher-ranked team that she has played for and cannot play for any lower-ranked team.
 - II. Remaining players in the registered team ("non-Core") may move up or down by one grade within their club (e.g. registered C team player cannot play higher than B or lower than D team).
 - o For example, should a club wish a Team C player to be able to play for A then they must seek WS consent to move the player's registration from C to B − same for going down.
 - Note above Dual Registered Players are an exception to this rule (either they are a Core Player anyway and if a non-Core player cannot move up or down either.
 - o If a non-core player is registered with a HockeyHK development team (Bauhinia /HKUHC), then they may only play up one team.
 - o If a non-core player is registered with the HockeyHK Masters, then they may only play up one team and no doubling up.
 - III. Up to [4] non-Core players from any team can play up to two games in a match week ("Doubling-Up")
 - IV. The Lower ranked team for whom a player is doubling up cannot have more than [12] registered players for that team in relevant match (including the doubling up player)
 - V. Doubling Up not permitted in last 4 league matches of the season of any team.
 - VI. However, teams may allow up to (no more than) 2 non-Core players to play in the last 4 league matches of the season of a team but those two players cannot play more than 1 match in that match week.
 - VII. This General Rule <u>does not</u> apply to any knockout tournaments (should be cup tied to first team player has played for etc as no player movement is permitted

between teams for KO unless exceptional circumstances and no unfairness to rest of league etc)

Definition of a Core Player

- Current HK Senior Squad Players
- Anyone who has played junior or senior international or provincial/state (or equivalent) in last x years (bearing in mind impact e.g. of an ex SA U21 player on div 1)¹
- o Top goal scorer of said team in any of the previous two seasons.
- o To reduce workload for WS and office Teams may change their Core Player list no more than [3] times in any given season.
- We expect clubs to cooperate and adhere to the experimental Bye-law in the spirit of Fairness - see the Aims of Fair Selection attachment below.
- All clubs agree that WS reserves the right to determine at any time whether a club is in breach of the Aims of Fair Selection. (Different penalties for first and subsequent breaches will be considered and drafted)
- Selection of a player to a higher team no restriction
- Selection of a player to a lower team than their registered team subject to restrictions (to be considered and drafted) and must not strengthen a lower team intentionally.
- Clubs agree if these rules come into play they expressly agree that HockeyHKWS can
 monitor team selections and movements on a weekly basis obviously WS must act
 reasonably when exercising discretion more details to be included about the type of
 circumstances when WS would intervene/apply penalties.

FAIR SELECTION & PLAYER ELIGIBILITY POLICY

1. Aims of Fair Selection

- 1.1. For Affiliated Clubs to have reasonable flexibility in managing player selection.
- 1.2. For an Affiliated Club's league teams to be selected in hierarchical order and be composed of players that reflects their level of ability within their club based on a) their availability on any one day and b) not being selected at a lower level than usual to strengthen a lower team.
- 1.3. For all clubs to feel competition is "fair" and that clubs are not disadvantaged by the application of these Bye-laws.
- 1.4. For players to be able to play and not be "unselectable" due to the Bye-laws.

Specific penalties for not complying with 3 principles of fair selection (Different penalties for first and subsequent breaches will be considered and drafted)

Club Alliance (schedule to competition Bye-laws – interim measure for 2 seasons only) Two single team Affiliated Clubs may submit with two weeks' notice a joint written request to the HockeyHKWS to form a "Club Alliance" either (a) two weeks prior to the start of the first winter league match of the season or (b) if (a) has passed, between [1-15]

¹ Most countries refer to 2 years experience but given size and level of the HockeyHKWS league it is clear players after 5/6 years still have a big impact.

December]. The Committee has two weeks to accept or refuse such request. Any refusal must be justified by the WS particularly if the following conditions are met:

- o The teams of each single team Affiliated Club are in different divisions;
- o There is no more than a two division gap between the two teams;

If the request is accepted the Club Alliance shall operate as follows:

- o For the purposes of the player registration and player movement rules only the two clubs shall be deemed to be a single Affiliated Club with two teams.
- o Team A shall be the team in the higher division and team B in the lower division.
- o Team A and Team B shall each nominate 9 Core Players subject to the same conditions as other clubs. Players shall be able to move between Teams A and B as per the Bye-laws and subject to the same restrictions therein.
- o Team A and B will also be able to benefit from the dual registered goalkeeper rule (Nominated Player) rules.
- o Fines are team specific. If a player is suspended they would be suspended from both teams etc.

If one of the teams play in the Premier Division and the request is accepted the Club Alliance shall operate as follows:

- For the purposes of the player registration and player movement rules only the two clubs shall be deemed to be a single Affiliated Club with two teams.
- o Team A shall be the team in the Premier Division and team B in the lower division.
- Team B shall each nominate 9 Core Players subject to the same conditions as other clubs. Players of Team B may be allowed to play up but players from Team A may not play down.
- Fines are team specific. If a player is suspended they would be suspended from both teams etc.

Player Passport – Experienced Players (schedule to competition Bye-laws – interim measure for 2 seasons only)

- o Only available to the three teams promoted into Premier Division in 2023/24 season;
- o Similar premise as what Bauhinia had this season in premier;
- Only available to them when playing any of the top 3 teams of 2022/23 season (HKFC A, Coyotez, KCC A);
- o No more than 3 on match card and no more than 2 on pitch at any time (similar to Bauhinia);
