- Discussion on the fees to be charged to players for the upcoming Asian Continental Cup and significant disappointment amongst attendees that HockeyHK are not prepared to help with funding of Masters.
- Requested Chairman to revert back to HockeyHK to get an explanation. Discussion as to whether better to revert to the former situation with Masters Teams in the Leagues, and options still being considered, with the restrictions on pitches meaning it will not be feasible for the coming season
- Early dates for Masters events to be confirmed and inclusion of Masters team in Easter Sixes and Summer Leagues should be pursued

There being no further items or comments the meeting was concluded at 8.20pm, with a planning meeting for the Asian Continental Cup following with all the participants.
